All FSS Participants are required to earn 12 participation points every year! Earn points by attending the monthly FSS Support Group! The next Support Group will be on Thursday February 17 at 6:30 p.m. in the Chapultepec Learning Center.

FSS GOALS:

and Services Plan (ITASP) Goals, the following goals must be completed by all FSS Participants:

- -Participate actively in the FSS Program as defined in your FSS Contract Addendum.
- —Complete the "Money Smart" financial education course or some other course of financial literacy instruction approved by the FSS Coordinator.
- —Achieve and maintain effective money management skills, as demonstrated by applying a budget and paying, by their respective due dates, rent and all utilities required by the terms of your lease, for at least three consecutive months before the end of this contract.
- —Improve credit rating by avoiding any new negative credit accounts and taking positive steps to improve or remove negative credit accounts as demonstrated by a reasonable increase in your credit score and/or qualifying for a home loan at a reasonable rate of interest, to be determined by the San Marcos Housing Authority.
- —Build family assets by making regular deposits into your savings account and by making no unnecessary withdrawals.
- -Meet with the FSS Coordinator each year to plan a budget for your federal income tax refund before you spend any of the refund.
- —Get and maintain suitable employment, for at least three consecutive months before the end of this contract, that is specific to [your] skills, education, job training, and the available job opportunities in this area.
