MOVING ON UP!

Rebecca Reyes is a familiar face to the Housing Authority. From July 2011 to February 2015 she was the Administrative Assistant in the Resident Services department and was at the Chapultepec office. Her duties not only included being the friendly face to residents and visitors at Chapultepec but she also answered incoming calls, delivered flyers and newsletters to residents, assisted in the processing of Family Self-Sufficiency Program (FSS) applicants, and maintained Public Housing and FSS files. The same year, she started working at Chapultepec, Rebecca also started in the FSS Program and has been working with Gracie Campos, one of our FSS Coordinators. Through the FSS Program, she has learned to budget and save money for her children's future, read and understand her credit report, and learned other ways to get to her goal of getting a house. Rebecca left her part-time job at the Housing Authority to take a full-time job with Young Williams Child Support Services, which is a contractor working for the Texas Office of the Attorney General. Rebecca told us, "Although my



position at Young Williams was very important to me, Gracie continued to help me find and apply for jobs that were more suited to my career goals." When a full-time position became available at our Section 8 office, she jumped at the chance and her experience with us and with Young Williams was a factor in her selection. Her new title is Housing Choice Voucher Specialist. She now maintains Section 8 files and does inspections on over 250 units throughout the year. Rebecca is enjoying her new position and is looking forward to the day she can afford to buy a home for her family. We are glad to have her back!

Lino Puente Ends His Term as President of the Springtown Villa Resident Council

Highlights From the April Meeting of the Board of Commissioners

FINANCIALS: The Public Housing YTD balance is \$65,323. So far we have spent \$495,328 on flood recovery at CM Allen. We have received \$68,786 from FEMA with \$223,852 currently in process. We received a \$70,000 donation from United Way of Hays County. The Section 8 program YTD balance is (\$11,816) but HUD balances the account on a quarterly basis and there is a positive balance of \$193,439 in "HUD-held Reserves." The Springtown Villa YTD balance is \$29,587.

OCCUPANCY: *Public Housing* - 213 units are occupied, 8 are vacant (96%). CM Allen units that have not yet been repaired and occupied are not included in the occupancy rate. 34 units are occupied at CM Allen. *Housing Choice Voucher* – 227 of 228 vouchers are leased up (100%). The Section 8 office will actually over-lease for a few months in order to balance at the end of the year. *Springtown Villa* – 60 of 60 units are occupied (100%).

NEW BUSINESS: HUD has issued a set of mandatory regulations known collectively as "Streamlining Administrative Regulations for Public Housing, Housing Choice Voucher, Multifamily Housing, and Community Planning and Development Programs," a.k.a. the "streamlining rule." Some of the new rules were already being practiced by the SMHA. Others require Board approval as they represent a change in current practice. Here is a summary:

~*Verification of Social Security Numbers* - When new families are admitted, if the PHA determines that good cause exists, parents may be allowed 90 days from the admission date to verify the SSN of children less than six years old.

~*Extremely Low-income Families* (ELI) – For families whose income does not exceed the higher of 30% of the area median income or the federal poverty level (based on household size), 40% of all new admissions to Public Housing must be ELI & 75% of all new admissions to the HCV program must be ELI.

~*Exclusions of Mandatory Education Fees from Income* – This will not affect public housing because all financial aid for post-secondary education is exempt income in that program. In the HCV program, the cost of tuition and mandatory fees are deducted from the student's financial aid but the remainder is countable income.

~*Earned Income Disregard* – Residents eligible for this income exclusion for new employment remain limited to 12 months of 100% disregard and 12 months of 50% disregard but it can only be spread out over a 24 month period instead of the current 48-month period, which allowed for disruptions in employment during that time. Now the clock starts at the time of initial eligibility and ends 2 years later regardless of employment status. This income exclusion applies to only certain Public Housing families and to families with disabilities in the HCV program.

~*Public Housing Rents for Mixed Families* – Corrects an error in how rent was calculated for families with persons who have not established an eligible immigration status. Now, if a mixed family's income-based rent calculation is greater than the maximum rent for that unit size (a.k.a. the "flat rent"), the PHA must use the higher rent.

~*Utility Payment Standards* – In the Housing Choice Voucher program the utility allowance will be the lesser of the bedroom size for which the family qualifies or the bedroom size the family actually occupies.

The Commissioners approved the new rules. They will become effective May 1.




GENEALOGY WORKSHOP
