Consent for Criminal Background Check

VOLUNTEER GUIDELINES

- 1. During volunteer time, I will focus my attention on the children.
- 2. I will be honest in recording the time and date I volunteered on paper.
- 3. I agree to dress appropriately around the children and make every effort to appear clean, neat and personally inoffensive.
- 4. I agree to be a role model and conduct myself in an appropriate manner with the children.

DO's and DON'Ts

- 1. **DON'T** use your cell phone during the program time. Unless you are expecting an important phone call or using it for a purpose of an activity, please don't use this time to text, talk, or listen to music.
 - **DO** keep your cell phone out of sight or in my office.
- 2. **DON'T** use any explicit language around the children. Even be cautious using words (especially around the younger children) such as "sucks", "shut-up", "stupid", etc.
 - **DO** use positive words that will encourage and strengthen a child's self-esteem.
- 3. **DON'T** wear anything that is too tight, too revealing, showing underwear, have graphic pictures or logos, or uncomfortable shoes.
 - DO wear clothing you are comfortable moving around in and shoes comfortable enough to walk, run, or play.
- 4. **DON'T** discuss topics that are inappropriate for children during the kid's program (including partying, drinking, bars, clubbing, etc). Remember: children are naturally curious and "nosey." They <u>are</u> listening and they <u>can</u> hear you.
 - DO engage children in conversations. Listen as well as talk.
- 5. **DON'T** let the children take advantage of you or push your buttons.
 - DO stand your ground, keep with the schedules and rules, and follow through with discipline.
- 6. **DON'T** yell at or handle a child in a physically inappropriate way.
 - DO make aware of boundaries (physical or otherwise) with the children.
- 7. **DON'T** let the children leave with anybody but their parent or whoever is authorized to pick them up.

REMEMBER:

- -Play and be a part of each activity! If you enjoy it, the children will enjoy it even more.
- -Don't be afraid to connect with the children.
- -You are the adult. You have more control of your feelings and the situation.
